**CHAPTER –1**

**INSTRUCTIONS TO BIDDERS**

- 1.1 Regional Director, Sports Authority of India (SAI) NSEC, Kolkata invites sealed bids for “DISPLAY OF HOARDING” for advertisement along the EM Bypass site at SAI NETAJI SUBHAS EASTERN CENTRE, KOLKATA.
- 1.2 The detailed specifications of the required Hoardings are given in CHAPTER – 3 of the Bidding Document.
- 1.3 The Bidding Documents duly completed in all respects should be submitted in sealed envelopes addressed to THE REGIONAL DIRECTOR, SPORTS AUTHORITY OF INDIA, NETAJI SUBHAS EASTERN CENTRE, SALT LAKE CITY, SECTOR-III, KOLKATA – 700 098 and should reach by the stipulated date and time as shown above.
- 1.4 The Late/vague/conditional/incomplete bids not conforming to the laid down procedure, or having any cutting/overwriting or discrepancy between words and figures in any respect, will be rejected. Mere acceptance of bid shall not amount to a binding contract and it is only upon execution of agreement deed that a binding contract shall come into existence.
- 1.5 The bid received after the specified date and time will not be considered under any circumstances. SAI shall not be responsible for any postal delays.
- 1.6 SAI reserves the right to reject any or all of the offers received without assigning any reasons and no claim shall be entertained on the grounds that any party has made the highest offer in response to the Invitation For Bids without incurring any liability whatsoever to the affected bidders and SAI shall be fully within its rights to issue a fresh Invitation For Bids.
- 1.7 In case of Partnership firms, where no authority to refer disputes concerning the business of the partnership has been conferred on any partner, the Bid and all other related documents must be signed by every partner of the agency/firm. A person signing the bid form or any other documents forming part of the contract on behalf of the another shall be deemed to warranty that he has authority to bind other partners and if, on enquiry it appears that the persons so signing had no authority to do so, the SAI shall without prejudice to other civil and criminal remedies cancel the contract and hold the signatory liable for all costs and damages. Each page of the Bid and the schedules to the Bid and Annexure etc., if any, should be signed by the Bidder.

**Bids should be submitted in three separate sealed covers as under:-**

**ENVELOPE –‘A’**

Shall contain Demand Draft/Pay Order of Earnest Money of Rs. 1,50,000/- (Rupees One lakh fifty thousand only). The EMD should be deposited in the form of Pay Order/Demand Draft issued by any Nationalized/Scheduled Bank in favour of REGIONAL DIRECTOR, NETAJI SUBHAS EASTERN CENTRE, SALT LAKE CITY, SECTOR-III, KOLKATA – 700 098 along with other details in the format enclosed at **Annexure-I**.

**ENVELOPE-‘B’**

Shall contain Technical Bid consisting of all technical details along with Technical Specification and terms & conditions. The Bidding Document duly signed by the bidder or his authorized signatory on each page should be submitted in the envelope- ‘B’ along with an undertaking as per the format given in **CHAPTER - 5**. The Technical Bid should be submitted in the format given at **Annexure – II**.

**ENVELOPE – ‘C’**

Shall contain the Financial/Commercial Bid indicating the price offered for “Display of Hoardings” mentioned in the Technical Bid. The format for submitting the Financial Bid is given in **Annexure – III**.

All the three envelopes should be put in one big cover duly sealed. Envelope ‘A’ & ‘B’ submitted by the bidders will be opened on the time and date as given in the Bidding Document. Envelope ‘C’ i.e. Financial/Commercial Bid of only those bidders will be opened, who meet the eligibility criteria as per para 2.1 to 2.35 of conditions of contract, chapter 2 and whose documents are found in order and the offer submitted by them is found acceptable by the Competent Authority. **CHAPTER – 2**

**CONDITIONS OF CONTRACT**

**SUBMISSION OF BID:**

- 2.1 The bids must be accompanied by a Bank Draft/Pay Order issued by any Nationalized/Scheduled Bank for Rs. 1,50,000/- (Rupees One lakh fifty thousand only) in favour of Regional Director, **SPORTS AUTHORITY OF INDIA**, Kolkata as **EMD** as mentioned in **Annexure - I**.
- 2.2 The Technical Bids shall be opened at 1500 hrs. on **30.1.2012** in the conference hall of SAI NSEC KOLKATA by a duly constituted Committee in the presence of such Bidders or their representatives who have submitted their Bids and may desire to be present at the time of opening of bids.
- 2.3 It is the responsibility of Bidders to read all terms & conditions of this document carefully before filling the bidding document. Incomplete bid or bids not responsive enough to the terms and conditions are liable to be rejected.
- 2.4 The Bids are also liable to be ignored if complete information as required is not given therein or if the particulars asked for in the schedules to the bid are not fully filled in. Individual signing the Bid or other documents connected with the DISPLAY OF HOARDING may specify whether he signs it in the capacity of
- i) a Sole Proprietor of the Agency/Firm of constituted attorney of such Sole Proprietor,
  - ii) a Partner of the Agency/Firm if it is partnership, in which case signatory of the bid must furnish a letter of authorization by way of Power of Attorney in his favour.
  - iii) Constituted Attorney of the firm if it is a Company
- 2.5 The schedules of the Bid Form should be returned intact and pages should not detached. In the event of the space provided on the schedule form being insufficient for the required purpose, additional pages may be added. Each additional page must be numbered consecutively and signed in full by the Bidder. In such cases reference to the additional pages must be made in the Bid Form. If any modification of the schedule is considered necessary it should be communicated by means of a separate letter along with the Bid. Overwriting/erasing in rates to be quoted by the Bidder will not be allowed; otherwise the Bid may be rejected.
- 2.6 The Bidder will make offer for Display of Hoardings per year. The total number of hoardings shall be not more than 30 (Thirty) in number one after another vertically on the allotted space and not more than of the size 40' x 20' each.
- 2.7 The financial bids shall be evaluated on the basis of Highest Bid Criteria as per scope of work (Chapter 3) subject to unconditionally agreeing to all other conditions of bid and the license/contract shall be awarded to the responsive Highest Bidder only. It is made further clear that the highest bidder shall be considered on the basis of the highest cumulative bid in terms of total amount offered for hoardings not more than 30 and irrespective of the number of hoardings bided.
- 2.8 If the Bidder fails to accept the Letter of Award issued by SAI NSEC, KOLKATA within 15 days, the Letter of Award shall be withdrawn and EMD will be forfeited. The period of license/contract shall start from the date of acceptance of Award of License by the Bidder.
- 2.9 That the License/Contract shall be for a period of 3 (Three) years and the rates may be quoted as per details mentioned in the Financial Bid – Chapter 7 (Annex-III)

**ELIGIBILITY:**

- 2.10 The bidder should have completed three similar works costing not less than Rs. 30,00,00/- or
- 2.11 The bidder should have completed two similar works costing not less than Rs. 37,50,000/- or

- 2.12 The bidder should have completed one similar works costing not less than Rs. 60,000,00/-
- 2.13 The bidder should have an annual average turnover of Rs. 3 crore during the last three years.
- 2.14 As regards work experience the bidder should have minimum three years experience in the similar type of Hoardings with Govt./Semi-Govt. Autonomous Institutions.

### **SCOPE OF WORK:**

- 2.15 The rates quoted by the bidder for the DISPLAY OF HOARDING in the Bid Document be mentioned both in words and figures failing which the same is liable to be rejected. The bidders are at liberty to be present or to authorize a representative to be present at the time of opening of the Bids
- 2.16 The bidder shall not display/advertise any items relating to cigarettes, tobacco, alcohol or alcohol drinks or any items, which may be considered indecent and objectionable by the SAI/Govt. of India and Local Authorities of the State Govt. of West Bengal.
- 2.17 The preparation and erection/installation of hoardings shall be at the cost and responsibility of the Licensee and the same shall conform to any Govt. orders, directions, rules, bye-laws or laws made by the SAI/Govt. of India/State Govt., or the Local Authority as the case may be, from time to time.
- 2.18 The Sports Authority of India shall not be responsible for the safety, security and the maintenance of the hoardings or for damage, injury or loss caused to property or the person of any other party and the Licensee shall be under obligation for all liabilities for which he will take appropriate insurance cover to safe guard against such eventualities.
- 2.19 The successful bidder i.e. Licensee shall be responsible for ensuring all measures, i.e., maintenance of hoardings, the safety of the site including structural safety and any person within the reach of the said hoarding and in case of any incident, injury or damage caused by the hoardings or any defects in its construction or its collapse, fall of any part of it, causing injury or damage to any person or to any property, the liability shall be entirely borne by the licensee.
- 2.20 The successful Bidder i.e. Licensee shall be responsible for obtaining all necessary permissions, clearances and authorization from the local authorities under the state laws from whom any such permission is required or prescribed by any authority competent to do so.
- 2.21 SAI will be merely issuing a License for the display of hoardings on its property but the said License shall not be construed in any manner as a deed of License for the land or the space or any property belonging to the SAI. It is clarified that even after issue of the License, the space on which the hoardings shall be erected would continue to belong to the SAI and no right with regard to this space shall vest in or accrue to the licensee for any use other than the Hoarding.
- 2.22 The prospective bidder, when granted License, shall make his own arrangement for Electricity from the concerned Local Body or install power supply system at his own cost. Licensee shall be responsible for payment of all the expenditure on account of the said electric connection including Electric meter Security any incidentals/Arrears of bills consequent to revision in Electricity Tariffs/defaulters/restoration of connection etc., and the electricity consumption.
- 2.23 The licensee shall not have any right what so ever for renewal of the license after the expiry of the license period and the licensor shall be entitled to invite fresh offers by an open advertisement in the newspapers well before the expiry of period of license.
- 2.24 Municipal Taxes, if any, payable on License Fee, to be deposited with SAI, will be borne by the Licensee.
- 2.25 The successful Bidder shall enter into an agreement with Sports Authority of India containing detailed terms and conditions, as may be specified in the agreement for the License, within 15 days after receiving intimation of acceptance of the offer and shall pay all expenses fees, stamp duties and other duties, incidentals thereon including the fees of the lawyers and shall be allowed to display the hoardings only after the License agreement has been duly concluded and signed.
- 2.26 The above terms and conditions are provisional and are not exhaustive and are liable to be amended, modified or added to at the time of agreement subject to the conditions as may be warranted at the time of signing of the agreement.

### **VALIDITY:**

- 2.27 **The offer of Bidder shall remain valid for acceptance up to a period of 90 days from the date of opening of bid (opening date inclusive).**
- 2.28 On the expiry of the License period, the Licensee shall be bound to remove the hoardings and handover peaceful possession of area on which the hoardings were erected within 7 days. On such peaceful vacation and removal of the superstructure of the hoardings by the Licensee, the Security Deposit shall be refunded to the Licensee within a period of 60 days from the date of removal of superstructures for the hoardings. Failing which the Sports Authority of India shall be entitled to confiscate such material which would be on its property after expiry of the period of 7 days. The Licensee, thereafter, shall not be entitled to any compensation/damages for the material not removed by him after the expiry of the aforesaid prescribed period of 7 days.

#### TERMINATION FOR DEFAULT:

- 2.29 If the performance of the bidder is not satisfactory during the currency of contract then this agreement may be terminated by SAI NSEC, KOLKATA after giving one month's notice to Licensee.
- 2.30 The successful Bidder shall not assign or make over any part of the License or allow any other party as a sub contractor to display their hoardings, without the prior permission of the REGIONAL DIRECTOR, SAI NSEC, KOLKATA. It is clarified that any such permission given by the Competent Authority shall be only with regard to the display of the hoardings/advertisement but shall not be construed as a grant of independent license to any such other party.

#### PERFORMANCE SECURITY:

- 2.31 The successful Bidder shall deposit an amount equivalent to 10% of the total value of the contract (Interest Free) as Security Deposit within 15 days of receipt of Award Letter. The amount of Security Deposit will be refunded within 60 (Sixty) days after expiry of the validity period of License Deed on handing over vacant possession as indicated in Clause 2.28 above.

#### RESOLUTION OF DISPUTES:

- 2.32 Should any dispute or difference of any kind arise between the Licensee and the SAI in connection with or relating to the contract, the parties shall make every effort to resolve the same amicably by mutual consultations.
- 2.33 If the parties fail to resolve their dispute or difference by such mutual consultation within twenty-one days of its occurrence, then, either the Licensee or the SAI may give notice to the other party of its intention to commence arbitration in the manner as hereinafter provided and the arbitration procedure will be as per the Arbitration and Conciliation Act, 1996 of India. The dispute or difference arising between the Licensee and SAI relating to any matter arising out of or connected with the License//Contract, shall be referred to the Sole Arbitrator to be appointed by the Director General, Sports Authority of India. The award of the Arbitrator will be final and binding on the parties to the Contract.
- 2.34 Venue of Arbitration: The venue of arbitration shall be the place from where the contract has been issued, i.e., Kolkata, India. The contract shall be governed by and interpreted in accordance with the laws of India for the time being in force.

#### PAYMENT:

- 2.35(a) The Licensee shall pay the license fee on quarterly basis, in advance latest by the seventh day of the month for the respective quarter to SAI, during the period of the license/ contract. The license fee for the first quarter of the contract shall be paid within 15 days of receipt of the Award Letter or at the time of signing the Agreement whichever is earlier.
- (b) In case of any default in making payment of License Fee to the SAI, by the Licensee, the SAI shall serve a notice for depositing the License fee within next 15 days, and if the Licensee fails to deposit the License fee within such extended period, this agreement shall be deemed to have been terminated being a breach of the contract and the performance security deposit will be forfeited. Licensee will hand over the vacant possession of the allotted space forthwith, failing which the Sports Authority of India shall be entitled to confiscate such material which would be on its premises after expiry of the period of 15 days. The Licensee, thereafter, shall not be entitled to any

compensation/damages for the material not removed by him after the expiry of the aforesaid prescribed period of 15 days.

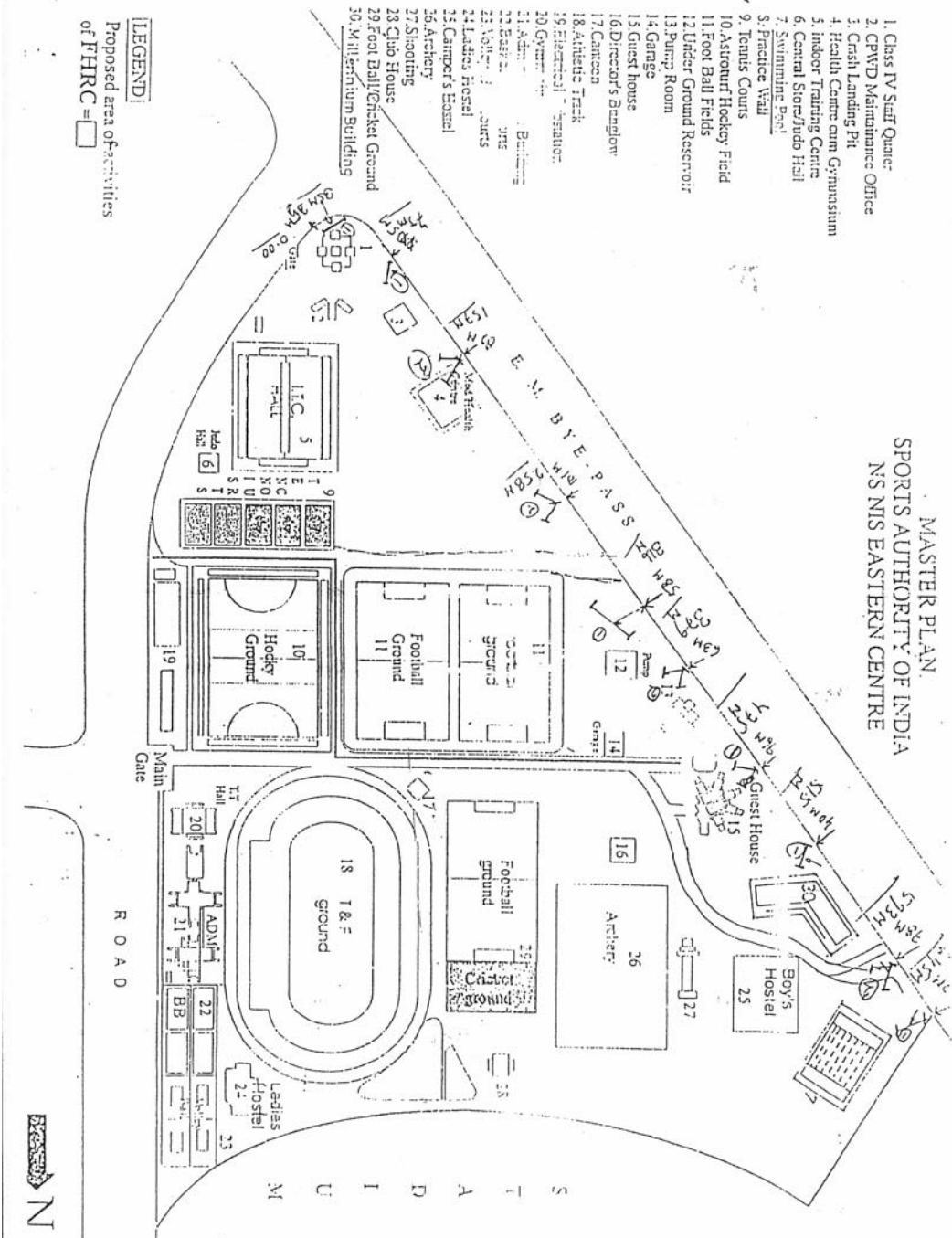
